

Workshop Policies and Procedures

Introduction

Derivan Pty Ltd holds education workshops, which are full day (five hour) sessions on a fee-for-service basis. Participants complete and lodge a Enrolment Form and make payment in order to attend a workshop.

Registration

Participants:

- confirm financial approval from their school
- check availability of course position by emailing a completed Enrolment Form to education@derivan.com.au
- enroll online www.derivan.com.au/resources/education.html fax or email.

Derivan:

- registers participants on receiving a completed Enrolment Form
- registration is on a first come basis
- class sizes are limited
- confirms and invoices participants prior to workshop
- provides a statement of attendance on completion of workshop

Workshop Fees:

- will be advertised in advance of workshops
- are paid on receipt of confirmation and invoice
- must be paid in full for registration to be valid
- are due five days prior to workshop

Cancellation of Workshops

It is recognised that cancelations or late withdrawals are sometimes necessary. Derivan reserves the right to cancel a workshop due to unforeseen circumstances or if the numbers of registrations is insufficient. If a workshop is cancelled due to unforeseen circumstances Derivan Pty Ltd will contact registered participants as soon as possible.

A full refund of fees paid will be provided where a participant gives more than 5 working days' notice of non-attendance.

Derivan Pty Ltd reserves the right to review individual applications for refunds for cancelled workshops on a discretionary basis. Refunds will be processed within five working days. A late withdrawal fee may be charged if advised less than 5 working days. Late name changes for replacements are acceptable.
